



Standard Terms and Conditions of Sale

TERMS AND CONDITIONS:

Purchases of products from Harcourt Industrial, Inc. ("Harcourt") will be governed by the Terms and Conditions outlined below, except as otherwise expressly set forth in a written agreement between the customer and Harcourt. No other agreements or understanding, oral or written, in any way purporting to modify these terms and conditions, whether contained in buyer's purchase order or elsewhere, shall be binding on Harcourt unless specifically agreed to in writing by an officer of Harcourt.

RESELLER POLICY:

Harcourt currently supports our market on a direct-to-industry basis which provides our customers with the highest level of service and care. Becoming an approved Harcourt reseller requires specialist training to ensure continuous satisfaction with the end user. PAYMENT:

If credit is extended, the customer agrees and understands that all invoices are due and payable within the agreed terms from the invoice date. A 1.00% processing charge will be added to all invoices paid by credit card. A finance charge at 1.5% per month (annual rate of 18% per annum) will be charged on balances over the agreed terms. If customer fails to make payment within the agreed terms, Harcourt may defer shipments until such payment is made, or may, at its option, cancel all or any part of unshipped orders. Should suit be instituted by Harcourt or their authorized representatives to collect any debts of the customer, the customer agrees to pay all actual costs of collection and attorney's fees and interest on past due amounts at the highest rate allowed by law. If credit is not extended, payment must be made by check upon receipt of goods, or by credit card with order placement.

RETURN POLICY:

All standard catalog items may be returned within thirty (30) days from sale, provided they have not been used or modified and are in resalable condition. Returned goods may be subject to a 20% restocking charge. Any return of excessive quantities of standard catalog items may be refused at the discretion of Harcourt. Returned goods must have prior written authorization and be accompanied by a copy of our Shipper/Packing List. All shipments without a prior written return authorization and a copy of our Shipper on or in the package will be refused. Any discrepancies in your order (shortages, damages, wrong parts, etc.) must be brought to our attention within five (5) working days after receipt of goods. Custom made or special items cannot be returned.

CANCELLATION POLICY:

If an order is cancelled through no fault of Harcourt there may be a restocking charge or production cancellation charge. These charges are applied to offset the costs incurred by Harcourt for handling and/or production work already performed. Special, custom or non-stock items are non-cancelable and non-returnable 24 hours after the order is acknowledged.

BACK ORDERS:

All items temporarily out of stock will be backordered. Backordered items are placed on expedite and will shipped as soon as possible. If an order is not requested to ship complete, multiple backorder shipments may be made as items become available.

PRICING POLICY:

Quantity discounts are available for many parts. Prices on blanket orders will be based on the quantity to be released for each shipment. Prices are subject to change without notice. Quoted prices will be valid for thirty (30) days, unless otherwise specified.

PART NUMBERS:

All part numbers referenced on any document(s), whether it be on purchase orders, quotations, or any other forms are strictly descriptive only.

ADVICE:

Harcourt assumes no obligations or liability for assistance given or obtained in connection with any goods sold. All such advice or assistance is given and accepted at purchaser's risk. Any decision as to use or installation of goods hereunder is that of the purchaser.
